8. OVERVIEW OF PROCEDURES

a. Rules of Order and Plenary Procedures

Goldfinch provided a brief overview of Robert's Rules of Order, the system of meeting rules and procedures that the Federation employs for plenary sessions, plenary sub-committee meetings and caucus meetings. She also reviewed relevant standing resolutions. Refer to standing resolution 3.

b. Anti-Harassment Procedures for the General Meeting

Anti-Harassment Advisors, Bofta Haile and Melissa Theodore, said that the Federation endeavored to create an environment at its national general meetings free of harassment. They said that at each national general meeting, the Federation employed at least one Anti-Harassment Advisor who would be available on a 24-hour basis to assist delegates.

c. Presentation by the Federation's Staff Relations Officer

National Treasurer Peyton Veitch, explained that he served as the Staff Relations Officer for the Federation. He said that the staff of the Federation are unionized with the Canadian Union of Public Employees Local 1281 and that the relationship between the Federation and its staff was governed by a collective agreement.

Whereas the decision further noted that "it would be easy to envision any number of situations ... in [which] it could be argued that the requirements prescribed by the Bylaws [of the Federation] lead to hardship or unfairness" for some students; and

Whereas the decision was, despite this criticism, ultimately favourable to the Federation; and

Whereas, in light of this decision, the Federation should permit the use of electronic voting in conjunction with the continued use of paper ballots; therefore

Be it resolved that Bylaw I.4.f.i be amended to read:

Voting must be conducted both electronically and by paper ballot, such that a voter may vote either on their personal electronic device or at a polling station. Electronic voting must be administered by a third party chosen by the Chief Returning Officer. Subject to an agreement between the Federation and the local student association, voting may also take place at a general meeting of the local student association or by mail-out ballot.

Voting must be conducted both electronically and by paper ballot, such that a voter may vote either on their personal electronic device or at a polling station. Whereas attempting to prevent a vote from taking place is anti-democratic; and

Whereas "counter-petitioning" is not and has never been explicitly permitted by the Bylaws, and should now be explicitly prohibited; therefore

Be it resolved that Bylaw I.6.a be amended to include:

No representative of the Federation or representative of a local student association may encourage a student to request that their name be removed from a petition.

Be it further resolved that Bylaw 1.3.a.ii be amended to read:

The students collectively belonging to a local student association will have sole authority to initiate, by petition signed by not less than ten percent (10%) of such students and delivered to the National Executive, a vote to certify as described in Bylaw I, Section 4. A student may request that their name be removed from a petition. If the National Executive receives such a request in writing, before the conclusion of the verification process of the petition, the name must be struck from the petition. The name shall not be included in the total number of names on the petition. No representative of the Federation or representative of a local student association may encourage a student to request that their name be removed from a petition.

Whereas the last audited financial statements presented to any semi-annual general meeting were the statements for the financial year ending June 30, 2013; and

Whereas close to one third of a decade—three years, three months and one-week (as of October 7)—has passed since the end of the last fiscal year for which audited financial statements have been presented for consideration to the member student unions; and

Whereas the audited financial statements serve as a fundamental basis on which the member student unions make decisions about the future of the organization; and

Whereas the audited financial statements serve as a fundamental basis for the member student unions to judge the performance of the elected board members, especially those who may be seeking re-election; and

Whereas in order for the Federation to function democratically as the Constitution and Bylaws envision, the Bylaws, Policies and Standing Resolutions of the Federation, and the Canada Not-for-profit Corporations Act, establish the voting members' right to information, particularly financial information, in order for them to make sound financial decisions; and

Whereas in the absence of audited financial statements the member student union have been functioning in a proverbial vacuum when trying to make financial and related decisions for the past two years; and

Whereas as a consequence one must reach the obvious conclusion that the Federation has ceased to function as a democracy insofar as representatives at Federation general meetings and even elected board members have been deprived of the information necessary upon which to represent their constituents; and

Whereas "taxation without representation" cannot be tolerated, whether in the case of a government or an organization within civil society; and

Delegate questions the financial documents on the website, the letter from the auditor, and a lengthier budget. National Treasurer responds clarifying the budget will be circulated Tuesday and that the letter from the auditor changed in formatting and date only.

Delegate posed a question regarding how the CFS will hold the Federal Government to account regarding their announcement of ninety-million-dollar funding for Indigenous education. Chairperson responds indicating that National Executive members will be following up with the appropriate Ministerial offices throughout the year and during Lobby Week in particular.

Delegate questions status of decertification petitions. Deputy Chairperson responds that the omission in the National Executive Report was an oversight, but clarifies there have been petitions verified and referendum dates proposed however due to fees being withheld by BCFS referenda could not yet be scheduled.

Delegate asks whether there any plans to update the End The Ban campaign. Deputy Chairperson gives update regarding the current state of the blood ban and how the campaign has changed to reflect that.

Delegate question regarding the selection of anti-harassment offers and their credentials. Chairperson responds that anti-harassment officers are selected based on their previous experience in general meetings who uphold the anti-harassment policy of the Federation, they can refer situations to professionals where necessary.

Delegate wonders how work with Labour partners will continue moving forward with the Fight For \$15 Campaign. The National Treasurer responds that we must continue to build upon connections built around the National Day of Action in several campaigns. The National Executive commits to working with \$15 and Fairness to expand the campaign on campuses.

Delegate asks for more information regarding access to tri-council funding for international students and what work is being done on eliminating fees for international students. National Graduate Caucus Chairperson indicates there is push-back in Lobby efforts in eliminating differential fees for International students, the Fairness for International Students campaign is being redesigned and will highlight including International Students for tri-council funding and include lobbying at the provincial level, to collaborate between the graduate student caucus and international student constituency.

Delegate questions how undergraduate students can amplify the campaigns of graduate students. National Graduate Caucus Chairperson responds that the student-worker coalitions can include graduate students, we can learn what strategies work for locals that represent both

undergraduate and graduate students and learn about issues such as Copyright and Anti-Corporatization campaigns.

Delegate echoes the sentiment of many previous speakers by thanking the National Executive for their work. The delegate's question is how can services of the Federation be better promoted in order to reach members. The Deputy Chairperson responds that the CFS has produced customizable pamphlets and other materials over the past year and will continue to do so, as well, negotiation of block health and dental plan coverage for graduate students' unions has begun in order to better service graduate students. New staff have been hired to assist and promote the services of the Federation.

Delegate wondering about how announcement of free college education for students in New York impacts organizing in the Canadian context. The Chairperson applauds the work of the United States Students' Association, and comments that students in Canada must build on that momentum, goals for the Federation will be set in the upcoming Campaign's Forum. The National Graduate Caucus Chairperson notes that municipalities have taken a role in New York victory and that we should work with municipalities in Canada as well.

Delegate wonders about the status of the Where's the Justice Campaign of the CIRCLE. Incoming Chair of the CIRCLE indicates interest in having more Indigenous students partake in Lobbing efforts, working with partners such as Idle No More. Outgoing Chair of the CIRCLE indicates that a Lobby Document was created with input from members of the CIRCLE.

Delegate wonders why members of the National Executive attended their campus. The Deputy Chairperson indicated that the purpose of the visit was to promote free education, as well as services and campaigns of the Federation.

Delegate asks about the lobbing goals to end unpaid internships are for the year. National Treasurer responds that although unpaid internships will be eliminated in the federal sector it excludes internships that are part of a course credit program. The National Treasurer met with coalition partners at the CLC Convention and the Federation will continue to work with organizations which advocate for the elimination of unpaid internships.

Whereas one of the Federation's longest standing campaigns, *Where's the Justice?*, aims to decolonize with the goals of increasing access to education for First Nations, Metis, and Inuit peoples, while protecting water, land, and people from encroaching development; and

Whereas the Federation declared its solidarity with land- and water-protectors opposing the Muskrat Falls project in Labrador, following a resolution at its November 2016 semi-annual meeting; and

Whereas the Federation voiced this support in letters to the provincial governments of Newfoundland and Labrador, and Nova Scotia; and

Whereas the Muskrat Falls project has proceeded to advance despite the calls of indigenous leaders and experts; and

Whereas the community of Mud Lake, Labrador flooded in mid-May; and

Whereas the cause of the flood is currently unknown do to a lack of data, but experts are suggesting it is because the protection of the dam infrastructure was prioritized over preventing a flood in the area; and

Whereas dozens of Land Protectors, including Inuk elder and grandmother Beatrice Hunter have been charged for their actions in opposition to the project and in defense of their land, health and safety and traditional ways of life; and

Whereas Justice George Murphy ordered Beatrice Hunter to be taken into custody when she defiantly refused to agree not to go near the Muskrat Falls site; and

Whereas Beatrice Hunter has been forcibly removed to a maximum security prison for men over a thousand miles away from her home, family and community, where she is subject to stripsearches meaning that not only is the Muskrat Falls project stealing land and water, but now people as well; and

Whereas Beatrice Hunter was resisting as a duty to her people, teaching her people the importance of the land and water to her people; and

Whereas the detention of Beatrice Hunter for protecting her water and lands is in contradiction to the recommendations of the Truth and Reconciliation Committee, and the United Nations Declaration on the Rights of Indigenous Peoples: therefore

Be it further resolved that the Federation call upon the governments of Canada and Newfoundland and Labrador to free Beatrice Hunter and drop all charges against her and the Labrador Land Protectors; and

Be it further resolved that the Federation call upon the governments of Canada, and Newfoundland and Labrador to formally apologize to Beatrice Hunter, and all the Labrador Land Protectors who have been unjustly charged; and

Be it further resolved that the Federation call for the removal of Justice George Murphy from the Supreme Court of Newfoundland and Labrador; and

Be it further resolved that the Federation donate \$1000 to the legal defence fund of Beatrice Hunter.

Whereas the amendment to Bill S-3 made by the Senate Committee on Aboriginal Peoples on May 17, 2017 (the "61)(a) amendment") would address the long-standing discrimination against Indigenous women and their descendants in the registration provisions of the Indian Act.

Whereas the history of this sex discrimination; it has been a long-standing shame to Canada that Indigenous women and their descendants do not enjoy equality with their male counterparts with respect to Indian status and the transmission of status. This discrimination was commented on in reports on discrimination against women in Canada as early as 1970 when the Royal Commission on the Status of Women issued its report; Canada has been urged repeatedly by the United Nations treaty bodies to remove this discrimination completely and finally.

Whereas we honour the many Indigenous women, including Mary Two-Axe Early, Jeannette Corbiere- Lavell, Yvonne Bedard, Sandra Lovelace-Nicholas, Sharon McIvor, Lynn Gehl and many others, who have spent decades fighting to remove the discrimination and get the same entitlement to full 6(1)(a) status as Indigenous men and their descendants.

Whereas the Bill-S-3 without the Senate Committee's amendment does not address the root of the problem of sex discrimination in the Indian Act, but only represents one more "piecemeal" fix for a group that had to battle for rights in the court. Bill S-3 without the Senate Committee's amendment is not an adequate response from your Government to the continuing discrimination.

Whereas the current Bill S-3 will greatly impact our future generations by the way in which no one will have Indian Status in 50 years. This is an assimilation tactic of today to alleviate the responsibility that the Government has to Indigenous Peoples. We do not see why more generations of Indigenous women and their descendants should need to carry on this struggle.

Whereas this does not only affect Indigenous women it affects their male descendants as well. We are excluded from our communities based on these codes, which in turn, are unable to vote, run for band council, Chief of our communities or run in the Assembly of First Nations Elections. We are unable to live in our communities.

Be it Resolved that Federation fully support and endorse the Senate Committee's amendment, which has been called "6(1)(a) all the way," because it will give Indigenous

Whereas the Board of Regents of Memorial University passed a budget proposal on May 11th that cut academic and front-line staff by \$13.4M, that imposed 3, and lifts the tuition fee freeze by increasing tuition fees for new out-of-province and international students by 30% beginning in Fall 2018; and

Whereas the introduction of differential fees for out-of-province students represents an increase represents an increase for domestic students of \$2550 to \$3515, and from \$8800 to \$11440; and

Whereas informed, meaningful, and urgent input from students, faculty and staff at the public town hall hosted by MUN Administration was largely ignored; and

Whereas only 1 of 4 student regent positions were filled during the time of the meeting, with the other 3 pending approval; and

Whereas the Administration of Memorial University has a well-documented administrative bloat that has gone unchecked for years; and

Whereas the provincial government of Newfoundland and Labrador has been backing away from its obligation to fund post-secondary education, defunding Memorial University by roughly \$54M; and

Whereas Newfoundland and Labrador has maintained a tuition freeze since 1999, and has long been used by student activists in other provinces as an example of how sound public policy on post-secondary education and direct action can withstand changes in government, and weather abysmal economic realities; and

Whereas the Canadian Federation of Students opposes financial and social barriers to post-secondary education; therefore

Be it resolved that the Canadian Federation of Students condemn the Board of Regents and Administration of Memorial University for downloading the cost of education onto students.

Be it further resolved that the Canadian Federation of Students condemn, in writing, Dr. Gary Kachanoski, President and Vice Chancellor of Memorial; Dr. Noreen Golfman, Provost and Vice President Academic; Kent Decker, VP Finance. These letters would also express the urgency for MUN senior administration to work with MUNSU in securing government funding;
